Dennis Patrick Glancy, 73, of Fremont died Saturday, August 4, 2012 at the Hospice House for Wapello and Davis Counties in Ottumwa. He was born Wednesday, September 7, 1938 in Bridgeport, Connecticut, the son of James and Eleanor Farrington Glancy. He graduated from high school in Bridgeport. Following school he served in the U.S. Marine Corp. from 1955 – 1957. Following his discharge he went to work at Sealtest Dairy in Bridgeport. On November 1, 1958, Dennis was united in marriage to Judy Kenny at Our Lady Of Good Council Church in Bridgeport. In the mid 60's he began driving semi and worked several places including Global Van Lines, DRS Transport, and lastly he worked at Fedex in Ottumwa pulling doubles. Dennis retired in 2006.
